You or your eligible dependent(s) **must notify the Fund Office** of your intent to continue coverage **within 60 days of receiving notice** that your coverage has lapsed by completing this election form and **returning it to the Fund office with your first payment**. Your **first payment** is required no later than 45 days after the 60 day election period and will be retroactive to the date your coverage lapsed. Subsequent payments are due in the Fund office on the first day of the month for which you are making payment. If payment is not received within 30 days after the due date, your coverage will terminate as of the last day of the previous month and cannot be reinstated. **YOU WILL NOT BE BILLED AND COVERAGE CANNOT BE CHANGED AFTER THE INITIAL ELECTION.** You may continue coverage for 18 consecutive months from the date coverage would have otherwise ended.
